This is to apprise you of the Circular No. 2022/E (Sports)/RSPB/1/51/CKT dated 13.02.2026, published by the Railway Sports Promotion Board soliciting compulsory participation of all the concerned sports association of the Indian Railways from 8th March 2026 to 14th March 2026 (Group Stage) and further from 23rd March 2026 to 31st March 2026 (Knock-out Stage).

In view of aforesaid, several affiliated clubs have urged the association to amend both 1st & 2nd Division League Championship fixture in a manner such that no 'On Duty' players fail to pitch in for the individual club(s) at the knock-out stage.

Consequently, the association is of the view that such amendments be made out only for the Railway Sports Association teams as well as for all the 1st Division affiliated Clubs as one of the subsisting precedents of its kind.

Under the above arrangements, the Association is inclined to defer the 1st Division League Championship Play-Off up until 2nd April, 2026.

Further, we intend to release the fixtures for the 1st Division League Championship Play-Off matches at the latest by 20th March, 2026.


Under the above arrangements, the Association is inclined to defer the 1st Division League Championship Play-Off up until 2nd April, 2026.
