A meeting of the Senior Tournament Committee of the Association was held on 15<sup>th</sup> May, 2024 and 22<sup>nd</sup> May, 2024 to consider the complaint dated 5<sup>th</sup> of May, 2024 filed by the Umpires and Match Observer against you for showing dissent at the umpire's decision repeatedly by your actions and also verbally using abusive languages towards the umpires by charging towards them in the match between Town Club and Kalighat Club on 3<sup>rd</sup> - 5<sup>th</sup> May, 2024 at '22 Yards Sports School Ground'.

Based on the complaint, you were requested to appear before the Senior Tournament Committee on 15<sup>th</sup> of May 2024. However, by an email dated 15<sup>th</sup> May, 2024 you expressed your inability to appear before the committee citing family problem.


The Senior Tournament Committee considered your prayer and directed you to appear for the subsequent hearing on 22<sup>nd</sup> May, 2024. Surprisingly you preferred to physically abstain from the hearing. Accordingly, during the course of hearing you were contacted virtually and you admitted that you had committed a wrong and tendered apology and assured that it will not be repeated in the future.

The committee after hearing you, the Umpires & the Match Observer have found you (Mr. Sandeep Kr. Tomar, Player Code: 8978) guilty of violating Rule 26, Code of Conduct of the CAB Administrative Rules, 2023.

The Committee after due consideration of all aspects and taking into account your offence has unanimously decided that you will be suspended for the upcoming 4 (Four) matches of CAB Tournaments i.e. CAB League, Knock-Out & J. C. Mukherjee Trophy, whichever is earlier.
