The Cricket Association of Bengal (CAB) invites Expression of Interest from reputed firms for providing Sole Selling Rights for In-stadia Advertisement.

- 2. CAB reserves the right at its discretion to reject/accept any Tender/s without assigning any reason whatsoever.
- 3. CAB reserves the right to negotiate the amount of bid after opening the Tenders before offering the Contract in the larger interest of the Association.
- 4. The E-bidding Auction will start at **1 PM on 15th September, 2025** and will run as per the rules mentioned in the Annexure-"III" & Annexure-"IV".
- 5. The Tenderer shall not transfer or assign the advertisement rights either wholly or in part to any other party or person/s.
- 6. It shall be the sole responsibility of the Tenderer to obtain all the applicable Licenses and to ensure that all the statutory or the legal requirements, rules and regulations relating to the display of advertisements are fully complied with and the Tenderer alone shall be responsible for all consequences which may arise directly or indirectly on account of the breach or non-observance of any statutory or other legal requirements. The Tenderer shall keep CAB indemnified against any loss or damage, which CAB may incur or sustain on account of breach or non-observance of any statutory legal requirements or on account of any negligence on the part of the Tenderer or on the part of his workers/agents.
- 7. The Tenderer must strictly adhere to the following BCCI guidelines regarding branding on advertising/digital signage while staging international matches:
- I. The Tenderer shall not in any manner use BCCI proprietary names ("BCCI Names"), BCCI proprietary marks ("BCCI Marks") and other BCCI proprietary and protected content ("BCCI Proprietary Content") in their marketing communications or promotions. This includes BCCI logo, its marks, match scores, or match statistics.
- II. The Tenderer shall not feature any competitive league branding or content of any sport in any promotional, marketing and advertising material and activities, or their names, images, likeness or attributes in-stadia, concourse, gates and in any stadium structure.
- III. The Tenderer shall not display a brand on any application in stadia, concourse, gates and in any stadium structure which conflicts with the BCCI sponsor categories as follows:
 - a. IDFC FIRST Bank Banking, Banking Financial Company, and Non-Banking Financial Company.
 - b. Dream11 Fantasy Sports (including Fantasy Gaming and Fantasy Gaming Content)
 - c. Star Sports and JioHotStar: Broadcast & Media
 - d. Adidas: Athleisure wear, performance merchandise/equipment
 - e. SBI Life: Insurance & Aggregators
 - f. Atomberg: Fans, mixer grinders and safety locks
 - g. Campa Cola: Non-alcoholic cold beverages
- IV. The Tenderer shall not undertake a partnership or any kind of association with an entity that is in any way connected/related to an entity that is involved/operates, directly or indirectly, in the betting/gambling/real money gaming/tobacco/alcohol/cryptocurrency sector or is one which is likely to offend public morals such as, including but not limited to, pornography.

- V. The Tenderer shall not engage with any brands that may utilize its partnership with the staging association to propagate surrogate advertisements to promote any entity having any kind of association or operating/functioning in the non-permissible categories mentioned above.
- The Tenderer shall not use any branding or content which contains material related VI. to players, umpires, referees or other officials or other spectators in a manner which offends, insults, humiliates, intimidates, threatens, disparages or vilifies that other person on the basis of that other persons' race, religion, colour, nationality or ethnic origin.
- VII. The Tenderer shall not undertake a partnership in the same award category as extended to BCCI sponsors:
 - a. IDFC FIRST Bank Player of the Match and Player of the Series
 - b. Dream 11 Fantasy Points
 - c. SBI Life All-round performer
 - d. Campa Fours
 - e. Atomberg Best Fielder
- VIII. The Tenderer shall not promote a product or category, which is in violation with Indian law and will need to adhere to the prevalent law on advertising prohibited categories.
- IX. Second layer branding is not permitted above the LED Perimeter board. The start point of the branding should be 15ft from the top of the LED Perimeter board.
- X. Any kind of additional branding next to the sightscreen is strictly prohibited. BCCI at its sole discretion has the right to remove any such branding (Print or LED) found installed around the sightscreen.
- XI. The tier/roof branding boards has to be of the same size of the supporting wall and cannot exceed 5ft in height at any given circumstance.
- XII. Any kind of branding is not permitted near, behind or next to the player dugouts.
- XIII. No installation of additional LED Commercial Walls or similar structures is permitted. The only screens permitted in stadia are the Big screen and replay screen with integrated scoreboards, Linear Scoreboards, Digital sight screens and LED perimeter boards.
- XIV. Any content intended to be displayed on digital signages in stadia must be approved by the BCCI.

The Tenderer shall ensure that the advertisements displayed are not objectionable or obscene or in respect of banned and/or prohibited products, goods and/or merchandise. The Tenderer alone shall be responsible for the consequences arising from display of any advertisement found to be banned, prohibited, objectionable, and/or obscene and the Tenderer shall keep CAB indemnified against any loss or damage which CAB may sustain and the cost/charges and expenses which CAB may incur in this regard. The Tenderer shall take a written approval from CAB before the advertisement is displayed.

The Tenderer must know that BCCI (Board of Control for Cricket in India) has an agreement with sponsors for the International Matches during the period of this contract and they have exclusivity in mentioned categories. The Tenderer shall ensure that there shall be no conflicting advertisements during the Matches. The Tenderer shall be solely

liable and responsible for any breach in this regard.

- 8. The Tenderer will be allowed to bring the advertisement material at the Stadium not earlier than awarding of contract. The Tenderer shall ensure that no part of Eden Garden, the approach roads or the playing area inside Stadium is damaged, obstructed or encroached upon in any manner whatsoever.
- 9. The number of workers and employees of the Tenderer permitted inside the Stadium and other parts of CAB premises would be at the prior written request to CAB of the Tenderer to enable the Tenderer to hoist or put up the Hoardings and other advertising materials. On the day when the match is being played the number of employees/workers as deemed fit will be admitted against specially issued passes by the CAB bearing photograph of the employee/worker and countersigned by CAB. Such employees/workers shall be confined to the area designated and shall not be permitted to enter the playing area or the outfield except in an emergency and with the prior permission of the Secretary of the Association.
- 10. The Tenderer alone shall be liable and responsible to ensure that the advertising material is securely placed and fixed and does not cause any obstruction and/or disturbance to the game or vision of the players and spectators and is not a source of injury, danger or nuisance to anyone including any person who is admitted into the property of CAB including the stadium. The Tenderer alone shall be answerable for and keep CAB indemnified against any loss or damage which may be caused or suffered by CAB due to the default of the Tenderer and/or his employees and/or workers in this regard.
- 11. The Tenderer alone shall be liable and responsible for the safety of the advertising material and CAB shall not be liable or responsible for any theft, pilferage, damage or destruction caused to the same for any reason whatsoever.
- 12. The Tenderer shall get the advertisement material insured at his own costs and expenses as well as ensure that his employees/agents/workers at site are duly insured. The Tenderer shall also ensure that his employees/agents/workers deputed on the site are duly screened for security purposes and their names and particulars are properly recorded. CAB shall in no manner be liable or responsible for the safety and or acts of the agents/employees/workers of the Tenderer and the Tenderer shall be liable and responsible for the same.
- The Tenderer shall ensure that all the advertising materials are removed and the paintings are erased and property is restored to its original state within 48 hours after the conclusion of the match at its own cost. If any damage is caused to the structure and/or other property of the CAB or the playground in fixing, bringing or removing the advertisement material and/or if the advertisement material are not removed and/or duly effaced as stipulated herein above CAB may repair the damage and/or remove/efface the advertisement materials at the cost of the Tenderer towards which the Tenderer shall deposit with CAB a Sum of INR 25,00,000/-(Twenty Five Lakhs only) payable through a demand draft Nationalised/Scheduled bank encashable at Kolkata before the Tenderer is permitted to bring the advertisement material. The said deposit shall not carry any interest and shall be refunded after all the advertisement materials have been removed and damages if any, caused to CAB property are deducted therefrom. This is without prejudice to the rights of CAB to claim, demand and recover from the

Tenderer additional amount by way of such damages in case the sum of INR 25,00,000/- is not adequate to cover such claim.

- 14. If any match is cancelled prior to the day of scheduled commencement, the full amount for the said match shall be refunded by the CAB within one month of cancellation of the match. No interest shall be payable on the amount refunded. The Tenderer however shall not be entitled to any compensation or reimbursement of any loss or expenditure which the Tenderer may incur or suffer whether directly or indirectly concerning the said match. The defaulting Tenderer shall not be entitled to any benefit of this condition.
- 15. If the duration of the match is curtailed or the match is cancelled (except in circumstances mentioned above) or if the match is not telecast live, wholly or in part either due to rain, adverse weather, riot, civil disturbance, commotion, security requirements or any other cause or reason whatsoever or if the number of T.V. Cameras and/or their location is changed/altered or reduced the same shall not be a ground for cancellation of the Agreement or non-payment by the Tenderer of the whole or part of the amount of bid as the case may be and the CAB shall not be liable to pay to the Tenderer any compensation, or amount for loss or damage which the Tenderer may suffer or incur whether directly or indirectly in this regard.

Section of the EOI are mandatorily required to sign and submit two signed originals of the Online Auction Participation Consent (set out in Appendix-1 to this EOI) in order to be permitted to participate in the online auction process. The Eligible Bidders shall be provided with an 'E-Auction Process Document' with further details regarding the E-Auction process and the 'E-Auction Process Document' shall form an integral part of this EOI.

- 2. The Service Provider shall provide online training to the designated representatives of the Qualified Bidders for the purpose of enabling them to familiarize themselves with the website/ portal designated by CAB for online submission of Bids ("Auction Engine") as well as participating in the online auction process. The designated representative of the bidders shall confirm in writing upon having undertaken the said training session conducted by the Service Provider.
- 3. Bidders will not be provided any information regarding how many persons have purchased this EOI and/or the identity of any other person who may have purchased this EOI.
- 4. Each Eligible Bidder shall be informed that it is an Eligible Bidder and the Package(s) for which it is an Eligible Bidder, prior to the commencement of the E-Auction. Eligible Bidders shall be permitted to submit Bids only for the Packages for which it is eligible to Bid as intimated to it by CAB prior to the commencement of the E-Auction.
- 5. The Eligible Bidders will be informed of the time of commencement of the online E-Auction. Login credentials will be issued to the newly registered bidders to their registered email address only. Login credentials will remain same for the bidders who are already registered with us.
