The quantity of the material shown in the said statement is tentatively worked out and the same is likely to be changed on physical verification.

- Quotation with offered rate, Additional taxes i.e GST & TCS, and total amount
- Signed declaration accepting all tender terms

4. Tender Fee (Non-Refundable)

- The bidder shall pay a non-refundable tender fee of INR 5,000/- by cash at CAB office. This payment must be completed one day prior to the date of the Physical Verification of Scrap i.e. 30th Jan-2026.

5. Payment schedule

- The Payment schedule shall be as per the table below: The selected Party pays the amount equal to 50 MT of Steel within 48 hours of declaration of the Bid winner. Balance of the Payment will be progressive with quantity between 50-100 MT picked up in each installment.

Terms and Conditions:

1. The Quotation should be submitted by 06:00PM before 2nd Feb-2026. In sealed cover to Association at Dr. B.C. Roy Club House, Eden Gardens, Kolkata, West Bengal 700021.
2. The contract will be given to the responsive and successful scrap dealers.
3. The Bidder Evaluation will be done at CAB discretion based on the credentials and commercials received.
4. The offers shall be given in the accompanying format.

5. The delivery of the waste and scrap material will be given only after the same is physically counted.
6. The successful contractor will have to deploy his own labour for loading and unloading etc.
7. The successful contractor should make his own arrangement of transportation at his own cost.
8. The entire operation of packing, loading & unloading and transportation & weighing shall be carried out by the contractor with his own resources, within the period of **30** days from the date of acceptance of Work Order.
9. The contractor shall keep the premises clean and tidy.
10. Levy of taxes if any will be the liability of scrap dealer like.
11. Tender shall remain valid for a period of 30 days. Successful bidder must pickup within 30 days from the date of submission.
12. The CAB will award the contract to the bidder whose offer has been determined to be substantially responsive and who has offered the highest rate.
 - a) Notwithstanding the above, the CAB reserves the right to accept or reject any offers and to cancel the bidding process and reject all offers at any time prior to the award of contract
 - b) The bidder whose bid is accepted will be notified of the award of contract, prior to expiration of the offer validity period. The terms of the accepted offer shall be incorporated in the Acceptance letter.

13. Penalty:

- a) For delay in pickup beyond 30 days— 1s % per week or part thereof after the expiry of the work order period subject to maximum 10%.
- b) In case if the contractor fails to remove complete delivery of the good sold or part thereof within stipulated period, he/they shall be liable to pay demurrage charges at 1% of the sale value of unremoved quantity per day. Notwithstanding the facilities given above, the CAB reserves the right to forfeit the amount paid by the Purchaser without any further notice and goods will be resold as deemed fit to the CAB.
- c) If the contractor personnel is found responsible for any theft, loss of material/articles and damages, he/she shall be liable to pay immediate payment in actual, equivalent to the value of the article theft/lost/damaged or replacements decided by the CAB depending on the gravity of the act.
