

NOTIFICATION REGARDING THE SCHEDULE OF EVENTS FOR THE CONDUCT OF THE ANNUAL GENERAL MEETING OF THE CRICKET ASSOCIATION OF BENGAL ON 29.09.2021 AT 5:00 PM.

In terms of the Constitution of The Cricket Association of Bengal (CAB), the following Procedure is hereby laid down for conduct of the 90th Annual General Meeting of the Cricket Association of Bengal.

Former International Cricketers may also submit Appendix-A in the same manner.
22.09.2021	5:00 PM onwards	Scrutiny of Appendix A Publication of draft list of representatives of eligible Affiliated Members and former International Cricketers qualified to attend and participate in the AGM.
23.09.2021	11:00AM to 5:00 PM	Submission of representations and/or objections, if any, to the published draft list mentioned above
24.09.2021	2:00 PM onwards	Consideration of the representations and/or objections, if any by the Electoral Officer.
27.09.2021	After 5:00 PM	Preparation of the Final List of the representatives of eligible Affiliated Members and former International Cricketers qualified to attend and participate in the AGM.
29.09.2021	05:00 PM	Scheduled convening of the 90 th AGM

Salient features

- 1 Only one authorised Representative of an Affiliated Member is entitled to attend and participate in the Annual General Meeting on 29.09.2021. The Representative of an Affiliated Member shall have to submit Appendix-A (Representation & Nomination Form) duly filled in and signed as per the schedule A.



A former International Cricketer may also submit Appendix-A in the same manner. However, an Affiliated Member who is former International Cricketer hailing from the State shall only be entitled to attend personally and cannot ALSO attend as the authorised representative of another Affiliated Member.

2. Procedure of submission of Appendix-A by Representatives/ Former International Players

(a) By Representatives of Affiliated Members of CAB who are nominated to attend and participate in the AGM:

Submission of Appendix-A (Representation & Nomination Form) with cols 1 and 4 duly filled in and duly signed by the Hony. Secretary of the Affiliated Member with his seal and also signed by the Chairman of the meeting. Any overwriting or cancellation of any entry should normally be avoided. In case of unavoidable circumstances, such overwriting or cancellation shall be authenticated by Hony. Secretary with his signature and stamp. If the name of the Representative has got to be changed, a fresh Appendix-A will have to be submitted and such fresh Appendix-A has to be taken from CAB Office on submission of application.

(b) For those Former International Players who desire to attend and participate in the AGM:

Submission of Appendix-A (Representation & Nomination Form) with his name mentioned in Col 1 and the form duly signed by him/ her. (optional).

3. During the process of consideration of the representations of such affiliated members whose representatives have been found to be ineligible by the Electoral Officer, such affiliated member may be represented by the concerned representative and a maximum of one other authorised representative who may be his/her legal advisor.
4. On the date of AGM, the authorised representatives shall have to bring with them original Photo Identity card issued by Competent Authority like Passport, Aadhar, Voter Card, Driving License.
5. Members are advised to take note of the Constitution of the CAB with regard to the conduct of the AGM.
